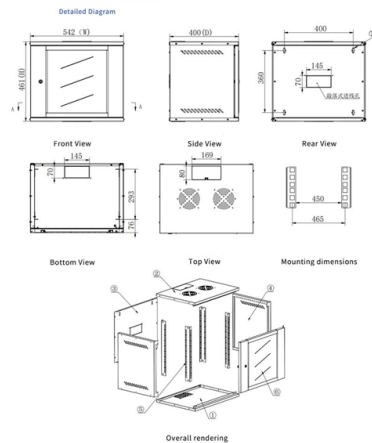


Is it legal to install optical modules in commercial buildings
